



93 ZRT (KZRT-FM) OFFICIAL GENERAL CONTEST RULES

1. ELIGIBILITY

Contests are open to legal U.S. residents who are 18 years of age or older unless otherwise specified. Employees, officers, directors, agents, and representatives of KZRT-FM, its parent companies, affiliates, subsidiaries, advertising agencies, and promotional partners, as well as members of their immediate families and those living in the same household, are not eligible to participate or win.

2. HOW TO ENTER

Contest entry methods may include on-air call-ins, online forms, mobile apps, social media platforms, text messaging, or in-person entries. Entries must be received within the stated contest period. The Station is not responsible for technical issues, incomplete entries, or failures of any kind.

3. WINNER SELECTION

Winners will be selected based on the criteria announced for each contest, including but not limited to random drawings, correct answers, or caller number. Decisions of the Station are final and binding in all matters.

4. WINNER NOTIFICATION

Winners will be notified via phone, email, or the method of entry. If a selected winner cannot be contacted within a reasonable timeframe, an alternate winner may be chosen.

5. PRIZES

Prizes are non-transferable and may not be substituted or redeemed for cash except at the Station's sole discretion. The Station reserves the right to substitute a prize of equal or greater value. Winners are responsible for all applicable taxes and expenses.

6. TAXES

Any prize valued at \$600 or more will require completion of IRS Form W-9 and issuance of a 1099 form. Winners are solely responsible for reporting and paying all applicable taxes.

7. ODDS OF WINNING

Odds of winning depend on the number of eligible entries received during the contest period.

8. PRIZE CLAIM

Winners must claim prizes within 30 days unless otherwise stated. Failure to claim a prize within the designated time will result in forfeiture.

9. LIMITATIONS ON WINNING

Individuals may only win once every 30 days unless otherwise specified. Only one winner per household is permitted during any 30-day period.

10. PUBLICITY

By accepting a prize, winners grant the Station permission to use their name, voice, likeness, and biographical information for promotional purposes without additional compensation.

Participants agree to release and hold harmless KZRT-FM and its affiliates from any claims, damages, or liability arising from participation in the contest or use of any prize.

The Station reserves the right to disqualify any participant for tampering, cheating, or violating contest rules. The Station may cancel, suspend, or modify contests at its discretion.

Contests conducted via social media are not sponsored, endorsed, administered by, or associated with Facebook, Instagram, or any other platform.

14. GOVERNING LAW
